



DEED OF ADDENDUM TO THE TRUST DEED

Clause No. 28:-

ACCOUNTING YEAR OF THE TRUST:-

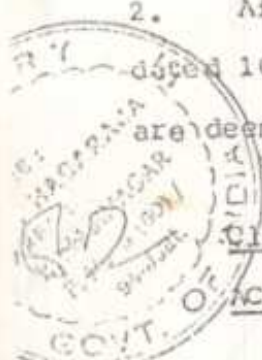
